



## CENTRAL ASIA-CAUCASUS FELLOWSHIP PROGRAM Spring 2019 Session Report

The Spring 2019 group of Fellows from Central Asia, the Caucasus, Afghanistan and Mongolia completed a sixweek program of high-level meetings and research in Washington, D.C. from April 2 to May 10, 2019. Since the fall of 2011, the Fellowship Program has partnered with the Open World Leadership Center to organize local programs with host communities outside of Washington, D.C. to help demonstrate American democracy on the grassroots level, how business and government work on the local level, and how people are empowered to take responsibility for themselves and others in their community. This spring the Fellows traveled in two groups to *Austin, Texas* and *San Antonio, Texas*. The entire group then traveled to *Chicago, Illinois* where the program included meetings with leadership and representatives of the *Kaplan Institute for Innovation and Tech Entrepreneurship* and private investment firm *Tilia Holdings*, as well as a meeting with Founder and CEO of ConantLeadership and former CEO of Campbell Soup Company *Douglas Conant;* a tour of Chicago's Technology and Entrepreneurship Center *1871;* and a meeting with the Larry Levy Executive Director of the Kellogg Innovation and Entrepreneurship Initiative at Northwestern University *Linda Darragh*.

In the final weeks of their program, the Fellows made a presentation at a Central Asia-Caucasus Institute Forum on the topic of "CAMCA: An Investment Harbor."

The next group of Fellows will visit Washington, D.C. from October 1 to November 8, 2019. The participants of the Fellowship Program for the Fall 2019 session will be announced this September.
